

SECOND SECTION OF TRAIL OPENS IN FINDLAY TOWNSHIP

Once again, the weatherman gives the Montour Trail Council a super day to see that another trail segment opens under sunshine. Sunday, July 18, 1993, saw festivities marking the opening of a 2.6 mile segment of trail in Findlay Township from the Enlow Ballfield eastward (or northward by the Montour Railroad nomenclature) to the Airport Parkway near the Montour Run Interchange. This brings the total mileage of the Montour Trail completed to 11 miles (Arrowhead Trail in Peters Township included). **DANGEROUS SITUATION**

Special ceremonies marking the opening began at 1:30 P.M. with Findlay Township Supervisor Joe Nester providing the welcoming remarks to celebrate the opening of the first section of the Montour Trail in Allegheny County. The Rev. Tom Petrosky of the Valley Presbyterian Church gave the invocation. Music was provided by the West Allegheny High School Band under the direction of Tom Snyder.



MTC President Stan Sattinger thanked Findlay Township for their contributions to the project after which MTC Board Member and Fund Development Chairman Tom Dougherty thanked Allegheny County and the other supporters who made this effort a success. Tim Killmeyer, MTC Board Member and Airport Area Coordinator, talked about the work done to complete the Findlay Segment and future development of the trail, west and east of this segment.

Following the speeches, the moment everyone was awaiting began with a procession to the trail gate where the Trail sign was raised and placed into pre-dug holes under the orchestration of Bill Metzger. Everyone was then invited to run, walk, or ride their bikes on the newly opened section of trail.

DANGEROUS SITUATION RELIEVED BEFORE TRAFFIC INCREASE

One of the remaining abutments of a Montour Railroad bridge that crossed Morganza Road in Cecil Township was obstructing the view of motorists at Hendersonville. The Montour Trail Council, aware of the hazard, worked with Cecil Township and the Pennsylvania Department of Transportation - District 12 to remove this obstruction. The work was completed just as traffic was being restricted on I-79 for the Southpointe Interchange construction. Motorists would be using Morganza Road (Washington Pike) to bypass the construction. Without the collaboration of PennDOT, Cecil Township and the Trail Council, this obstruction would still be in place and with the increased traffic, an accident would have been likely.

The roadway narrowed as it passed under the crossing and the vertical clearance was too low for trucks. But more importantly, there are three roads that meet Morganza Road (Cecil-Henderson Road, Railroad Street and Hahn Road) close to the crossing. Drivers trying to enter Morganza Road from these side roads had their vision obstructed because of the structure and were at risk of an accident.

The bridge structure had already been removed after several trucks hit the bridge, but the concrete abutments had been left standing. Before the Montour Trail Council would extend the Cecil Township segment eastward towards Chartiers Creek, this situation would have to be alleviated. (see ABUTMENT on Page 3)



The east abutment would remain to serve as an anchor for a replacement bridge. With help from Cecil Township and Sluciak Contracing, the embankment behind the west abutment was graded back leaving the abutment wall exposed and ready for removal.

PennDot arranged to have their contractor provide the operators and heavy equipment necessary to knock down the concrete abutment. Sixteen members of the Montour Trail Council and Cecil Township citizens volunteered to be flag persons after the project was to be shut down for the lack of flag persons. They accumulated over 250 hours of volunteer time during the three week period it took to complete the work.

The Trail Council plans to replace the bridge with a longer structure that will provide the necessary vertical clearance. A bridge that once crossed Conrail tracks near Irwin was carefully dismantled and stored by Middle States Steel Construction of Eighty-Four PA, for the Council. After Middle States offers a reasonable price to re-erect the trusses at Hendersonville, our volunteers may rehabilitate the bridge. Cecil Township has agreed to build the new abutment on the west side of the road for the replacement bridge.







THE FINDLAY SECTION

The Findlay Section is 2.6 miles between endpoints at the Enlow Ballfield along McClaren Road near Five Points and the Airport Parkway Interchange at the Montour Run. This section features the Enlow Tunnel which is 558 feet in length. Unlike the National Tunnel on the Cecil Section, this tunnel is straight. This section will connect up to the 5.4 mile Moon-Robinson section later this year when completed providing an 8 mile segment from Enlow to Groveton.

Findlay Township is looking forward to extending the trail westward to Imperial and working with North Fayette Township to extend the trail all the way to U.S. 22 at Champion, a distance of 4 miles.

MOON-ROBINSON SECTION OPENING SCHEDULED. Township officials have set Sunday, October 10, 1993 as the celebration marking the opening of this section. TRAIL COUNCIL HAS ANOTHER BRIDGE. Historic Little Pine Creek Bridge #7 on Fall Run Road in Shaler Township, Allegheny County has been disassembled and is being stored along the Trail for future use. The bridge was built in1896 and is in the National Register of Historic Places.

HOLT GETS \$20,000 GRANT

The Hollow Oak Land Trust (HOLT), a non-profit volunteer organization working to preserve land along the Montour Trail and other areas of western Allegheny County, recently received a \$20,000 grant from the Allegheny County Greenways Program. The funds will be used to purchase a 77 acre tract in the Montour Run Valley. The property is in Moon Township and lies along a ridge which can be seen from the Trail approximately half-way between Beaver Grade. and Hassam Roads. The land has many hiking trails and could someday serve as part of a link between Moon Park and the Trail. The acquisition is part of the Montour Greenway Project, the Trust's plan to preserve natural areas along the Trail from Coraopolis to the county line at Champion.

In order to raise additional funds needed to complete the deal, the Trust is holding a raffle for a home or business landscape design by JRM Associates, inclduing plant materials and installation for a total value of up to \$4000. A variety of prizes donated by local merchants will also be given away. The drawing will be held in December and the installation done in the spring.
