## A Tale of Two Floods: Rising Tide of Popular Support Overcomes Hurricane Ivan

The good news is that 2004 brought the Montour Trail Council an outpouring of public support unlike any we had seen in our first 13 years of operation.

The bad news is why we needed the extra help.

On September 17, 2004, the remnants of Hurricane Ivan unloaded nearly eight inches of rain on Pittsburgh's western suburbs. Torrents of water rushed down hillsides and overwhelmed Montour Run, washing out 10 miles of trail.

The damage was stunning, but so was the response:

- Numerous volunteers gave over 500 hours of their time to work parties aimed at rebuilding the trail.
- The MTC received \$18,000 in individual contributions designated to flood repair.
- The Laurel Foundation sent an unsolicited donation of \$25,000.
- The Allegheny Regional Asset District authorized the reallocation of grant funds to support the reconstruction.
- Findlay, Moon And Robinson Townships offered in-kind services to assist the rebuilding.
- Pennsylvania's Department of Conservation and Natural Resources came through with a commitment of \$50,000, greatly assisting with major trail reconstruction.

Hurricane Ivan showed more deeply than ever that the Montour Trail is the people's trail. Thousands of users lost a valued source of recreation when those 10 miles of trail were taken from them, and they gave generously to put the trail back together. Thanks to their efforts, as of June 2005 all but one of the lost trail miles have been restored.

### IKEA race just in time

Our ninth annual IKEA/Montour Trail half-marathon and 5K run/walk was undoubtedly our most challenging so far. First, we had to resurface 600 feet of trail and race surface after an August 23 rainstorm led to flooding of Montour Run. On September 8, just three days before the race, another downpour caused a heart-stopping evening but the stream crested just below flood stage.

The race itself went smoothly, with 1,060 participants--except that 41 of them never got to finish because an auto accident knocked down a utility pole along the course, forcing police to close the trail for safety reasons.

It could have been worse. Back in spring 2004 we debated whether to hold the race on September 18 or September 11 and decided on the earlier date. Had we chosen the 18th, Hurricane Ivan would have washed it out completely.

The spring Burgh's Run 10K and 2-mile walk enjoyed its fourth year, as over 300 participants helped to raise \$17,500 for the trail on April 25.

### National trail designation awarded

The Montour Trail was honored to attain designation as a "National Recreational Trail" by the U.S. Department of Interior. The timing of the award was especially significant, as a trail must be open to public use for at least 10 years before it can apply for designation. (As the first Montour Trail mileage opened in late 1992, the MTC became eligible to apply in 2003 and won approval within a year.)

To be designated part of the National Recreational Trails System, a trail must also be designed, constructed and maintained according to best management practices and in

compliance with applicable land use plans and environmental laws. NRT designation must also be supported by the landowners whose property the trail crosses.

"This designation recognizes the work of our all-volunteer organization in creating a trail that meets the nation's highest quality standards," said MTC president Dennis Pfeiffer.

### Capital improvements funded

The MTC received two major federal Transportation Enhancements awards in 2004, one to replace an aging bridge and one to expand the trail.

The MTC was obligated to remove the bridge over Muse-Bishop Road in Cecil Township to improve safety for the traffic passing underneath. The State Transportation Commission and Southwestern Pennsylvania Commission approved a \$400,000 grant to help replace the bridge, and PENNDOT cooperated with the MTC to establish a project timetable that should limit the trail disruption period to six months.

The second grant will be used to extend the Montour Trail in South Park Township, including the long-awaited renovation of the Library Trestle over Route 88.

### Web site improved

Led by board member Mark Imgrund, the MTC undertook a major initiative to make its web site more useful.
