Environmental study breaks loose first chunk of ISTEA funds

Trail Council to pay 20% of \$74,800 tab

In January 1993 the Montour Trail was approved for \$1,000,000 in Intermodal Surface Transportation Efficiency Act (ISTEA) funds. In January 1996, we will finally be allowed to begin the expenditure of those funds. After a lengthy review and approval process by PennDOT, a contract has been negotiated between Allegheny County (on behalf of the MTC) and SE Tech-

ogies, Inc. of Bridgeville, and is expected to receive final approval by the County in late December. This contract, in the amount of \$74,800, provides for the preparation of a comprehensive environmental report for the entire Montour Trail. Because the ISTEA funds are a Federal highway program, a report such as this is a necessary prerequisite to use of those funds for final design and construction

The task of SE Technologies is to investigate and document the impacts of the construction and use of the Montour Trail on the community and the environment. The areas of impact considered include Cultural Resources. Hazardous Waste, and Wetlands. Cultural Resources includes identifying historic or other significant structures near the trail and identifying potentially

significant archeological sites which the trail might impact. Hazardous Waste involves locating any places where past human activity in the vicinity of the trail has created the presence of substances considered hazardous and evaluating the degree of hazard. The Wetlands portion requires the location and delineation of any wetlands along the trail so that construction can avoid them. Finally, using the data developed, the report will summarize the effect of the trail on community development, cultural resources, wildlife habitat, ground and surface water resources, etc.

This all sounds pretty extreme for a walking/biking trail doesn't it? But remember, as far as ISTEA is concerned, this is a highway project. Most of us wouldn't want a highway built without these things being considered and we're just caught in the process. Our impact in terms of disruption of the communities' quality of life is minimal, as is our impact on wildlife habitat and water resources. We had a survey of potential hazardous waste along the trail done as a precaution prior to purchase, so we look for no surprises there.


AXA Riders use Trail on 'round the world journey

EDITOR'S

OBSERVATIONS

Talk about a big year for the Montour Trail Council! 1996 is here and with any luck at all more than half of the Trail will be off the drawing board and on the ground by the end of the year. Out of a total of 55 miles we already have 11 1/2 miles built in Moon, Robinson, Findlay, and North Fayette; 6 miles in Cecil; and 3+ miles in Peters Twp. With the 1 1/2 miles planned for South Park Twp. and the 6 miles planned for Robinson Twp., Washington County we will have over 28 completed miles of Trail. One stretch alone will be almost 18 miles long when we're finished this year. Almost 40 miles round trip entirely on the Trail! I can't wait.

But there's more. Allegheny County is negotiating an option on some property that will allow the Trail to go from Mile 0 in Groveton, back to Coraopolis and the bank of the Ohio River's back channel across from Neville Island. As things firm up we will let you know.

Money continues to be the stumbling block to completing more Trail in a timely fashion (isn't it always). But our fundraising committee has re-emerged with renewed vigor and several promising grant and foundation proposals have been put together with the hope of matching those ISTEA funds.

And remember, those grants are usually earmarked strictly for construction. There are still legal fees, postage fees, tractor payments, insurance costs, truck inspections, and maintenance costs for the sections of Trail already completed, to name but a few of the nonconstruction related expenses that the Trail Council incurs. These items all come out of our general operating fund which is maintained mostly by membership renewals and contributions. So if you have a friend who enjoys the Trail, please ask them to consider membership in the Montour Trail Council. No one else is going to build this Trail if we don't.


Enclosed in this issue of the TRAIL LETTER is a brochure that was produced by the Hollow Oak Land Trust (HOLT). HOLT is a non-profit organization working to conserve land in Western Allegheny County, especially along the Montour Trail. Many of you might have seen the HOLT plaque on the Trail near Mile Marker 2 identifiving one of HOLT's conservation areas. The Montour Greenway brochure is intended to raise the public's awareness of how the valley contributes to the quality of life for people of the region. It is also intended to alert people of the fact that the valley is vulnerable to irresponsible land use that

would ruin the Trail, stream, wetlands and wooded slopes; in other words, the features that make the valley a refreshing place to go to get away from the hectic, urban environment that surrounds it.

The Montour Valley is one of the last of its kind in Allegheny County and deserves special attention. We would all feel a great sense of loss if the same thing happened down in the "Heart of the Greenway" that is wappening right now to the hillsides and streams along the Parkway. We consider the "Heart of the Montour Greenway" to be the section of the Valley between Beaver Grade Rd. and Hassam Rd. where the landscape is

largely undisturbed. It is the wildest section of the Montour Trail in Allegheny County. How many of you have seen the breeding Mallards, the Great Blue Herons, the trout or the hillsides covered in trillium? How many of you would continue to use the Trail if parking lots and factories lined the edges? Please continue your support of the Montour Trail Council and the Hollow Oak Land Trust to help us protect this special, natural recreation area.



The meeting is being held to discuss plans to continue the Trail into Washington County from its current terminus in Findlay Twp. This will add six more miles to the Trail for a total of 27 1/2 miles from Groveton to McDonald. If you would like to see this project become a reality for 1996, please mark your calander and attend.

To get to Fort Cherry Elementary (behind the High School), take the McDonald exit of Rt. 22 and turn right on to 980 South toward McDonald. Continue past Quicksilver Golf Course another mile to the "T" intersection and turn right. Cross the RR tracks and turn right. Take the second left (at the main intersection) on to Fort Cherry Rd. Follow MTC signs. School is at top of hill

A reminder to WALKERS and CROSS-COUNTRY SKIERS:

WALKERS - Please do not walk in the cross country ski tracks. They are very hard to blaze and maintain. Boots and shoes dig them up and make them less smooth for gliding. Walk, run, and ride toward the middle of the Trail.

CROSS-COUNTRY SKIERS - Make your tracks to the far right hand side of the Trail (in either direction). They will be far less likely to be trod upon in that location.

When the report is finished in late 1996, it will be reviewed by PennDOT, a process that should take about six months. When finally approved, we can begin spending the ISTEA money on construction!

A final word on cost and reimbursement. ISTEA money is 80% from Federal highway funds, 20% from local match. To get the \$1,000,000 noted above, the MTC must raise \$250,000. As we spend (in increments) we are reimbursed 80% of what we have spent. We will be paying (through Allegheny County) the entire \$74,800 and will receive appropriate reimbursement upon completion of the study.


