MONTOUR WATERSHED PROJECT RECEIVES FUNDING

The Montour Valley Alliance recently received confirmation of funding for the upcoming Montour Run Watershed Planning Project. A grant of \$56,500 has been awarded under the Rivers Conservation Program of the Pennsylvania Department of Conservation and Natural Resources, and the Pittsburgh Foundation has provided an additional \$40,000 from its Peaceable Kingdom Fund.

The Watershed Planning Project, which is to be launched this summer, will emphasize community outreach. Area residents, hopefully including many MTC members, will participate in a series of Alliance-sponsored public meetings over the next 12 to 18 months. At these meetings they will be asked to identify concerns and provide information on problems and opportunities they see for the Valley.

Both the DCNR and the Pittsburgh Foundation funding will be channeled to the project through the Hollow Oak Land Trust, which is

acting as fiscal agent for the Alliance. Hollow

Oak Board Assistant Janet Thorne will act as Project Manager. The Alliance, which is a broad-based coalition of area organizations and citizens who want to protect and enhance resources while promoting compatible development in the Valley, was established as a Hollow Oak initiative and is chaired by MTC cofounder Stan Sattinger.

Much of the work required for the Watershed Planning Project will be performed by consultants. The end product is to be a master plan that details specific actions for protecting and enhancing the resources of the Montour Valley. Publication of this plan, and subsequent nomination of

Montour Run to the Pennsylvania Rivers Conservation Registry, could help fund solutions to flooding, contamination, and other problems that will be brought to light during the study.

Will Congress support trails?

In the next few months
Congress will consider decisions
with immense impact
on the future of the Montour
Trail--and of rails-to-trails projects
across the country.

The main federal transportation law, known as the Intermodal Surface Transportation Efficiency Act (ISTEA for short), expires on September 30. When first passed in 1991, it created a category of ten "transportation enhancements"—of which rails-to-trails is the largest—that receives designated funding.

These earmarked monies have comprised less than 2 percent of total federal transportation funding, but their contribution to the trails movement has been indispensable. A \$1 million ISTEA award to the Montour Trail Council is scheduled to begin funding continued trail development soon.

'97 IKEA 1/2 Marathon, 5K Run, and 5K Walk

Marshall Fansold, Dennis Pfeiffer, and myself have been working with Molly Bovard from Ikea, in the planning for this year's race. It's scheduled for Sept. 13, rain or shine. Last year there were 901 people registered in the three events. Four thousand dollars was raised for the Trail. Its namesake, IKEA, is the major sponsor. Race packets for those who preregister before Sept.5th, will be available to be picked up at IKEA in the lobby on Sept.10th and 11th, from 4 - 8 PM. This is to alleviate some of the confusion on race day.

The awards ceremony and breakfast will be held in a tent in the IKEA parking lot instead of inside the restaurant. A continental breakfast of bagels, fruit, juice, and Swedish coffee will be served.

Work ready to start at major intersection

After years of planning, design, and bureaucratic red tape, the Montour Trail Council and the Moon/Robinson Friends of the Trail are ready to undertake improvements at the Montour Run Road/Park Manor Blvd. intersection. The plans were designed by Trail Council member Bob Dudash of Robinson Township and approved by both Moon Township and PennDOT. They call for the existing guiderail around the intersection to be removed. A new guiderail, 25 feet long, will curve from the abutments of the bridge

miss the bridge from going into the creek on both sides of the Trail.

The Trail will curve toward the existing crosswalk at the intersection where a WALK/ DON'T WALK light and button are already in place. Special landscaping and a split rail fence will prevent people from using the old crossing, about three car lengths from the crosswalk.

If ment of trail projects." states are given this discretion, nonprofit groups like the MTC will be hard pressed to defeat pressure from the well-heeled highway construction community to spend all the money available on roads.

The MTC recently communicated with the two U.S. Senators and three U.S. House members who represent the region, urging them to

keep dedicated transportation enhancement funding in the reauthorization of ISTEA (commonly called NEXTEA).

We didn't get form-letter replies--which is both good news and bad news. It's good that the legislators and their staff paid us personal attention. But it's bad news that apparently

no other trails advocates had pushed some of these legislators to look at the enhancements issue seriously before we did.

Congressmen Frank Mascara (20th District) and Mike Doyle (18th District) provided

ng statements in support of the enhancements program. Doyle stated, "Earlier this vear. I joined with other Members of Congress to voice support for ISTEA's critical elements to [House transportation committee chairman] Bud Shuster. It is my strong belief that ISTEA

works, and I will do all I can to defeat adjustbuilders have sought to rewrite ISTEA so as to ments that abandon our shared commitment to enrich our community through the develop-

> Congressman Mascara, who is member of the House transportation committee, wrote that "Enhancements must not go neglected" and that he would advocate maintaining adequate funding for them.

Our two senators were somewhat more cautious in their replies. Rick Santorum, who spent half a day helping to build the Mon-

> Yough Trail in Elizabeth while he was a congressman, expressed continued support for rails-to-trails, and Arlen Specter wrote that trails priorities "should be taken into account" in the ISTEA reauthorization process. Neither, however, was ready to promise

support for dedicated enhancement funding.

As this newsletter went to press, the MTC was still awaiting a reply from Congressman Bill Coyne (14th District).

These exchanges reinforce how important House Office Building, Washington, DC it is for trails supporters to take just a few minutes to make their views known to their legislators. Don't ask us to give you a form letter to House Office Building, Washington, DC sign; legislators know they reflect minimal effort by the constituent. Phone your congressman and senators or, even better, write a short,

personal letter expressing why you believe continued funding of rails-to-trails is important and asking for a specific reply. The MTC would appreciate seeing a copy of any replies you receive.

If you don't know which district you live in, your local library, the League of Women Voters, or the MTC can tell you.


