Local Friends of the Trail get ready for Spring!

By the time you read this all the snow should be melted and the temperatures will be settling into the mid to upper fifties. While everybody else has been spending the last month or so tuning up their bicycles and buying new walking shoes, the various Friends of the Trail organizations have been planning ways to spruce up your favorite recreational area.

Although separated timewise by about 3 months, two huge trees fell about 50 yards from one another this year. This most recent one busted up some split rail fence. The Trail was kept open because Friends Bob Boyce and Dick Quasey cut them up with powersaws.

These localized Trail groups, sanctioned by the parent Montour Trail Council, are organized in communities where Trail construction has been completed. Members of the Trail Council are automatically members of the Friends group where they live or in the section of Trail that they use the most. Non-members who help the group

are encouraged to join the MTC.

The members of these Friends groups promote, maintain, and represent the Trail in their respective communities. This allows the parent Montour Trail Council to move on to complete more sections of undeveloped Trail. In past years the Friends have cut grass, picked up litter, cleaned graffiti, planted trees and shrubs, repaired fencing, installed

stream erosion protection and monitored Trail activities by various groups. (All groups must apply to MTC before holding events on the Trail.) They also man Trail information booths at local fairs and other community events.

There are currently three Friends groups in operation; the Cecil Friends of the Trail, the Moon/Robinson Friends, and the


Findlay/North Fayette Friends. Each presented their plan of action to the MTC board of directors in February as per their by-laws.

Top priority for the Cecil Friends is to complete the 1 1/2 mile "Hendersonville East" section that they started last year. This will continue the Cecil section of the Trail from its present terminus at Morganza Rd. on to the Peters Township border at Chartiers Creek. Work involved includes placing surface material and erecting fences. (Interesting note: The surface material was procured by Cecil Friends President Dennis Sims from The Meadows racetrack. He got permission this past winter from track superintendent Corwyn Greene to obtain the used 1-A limestone from the horse racing oval. This is believed to be the first time used race track material is being used on a rail-trail - ANOTHER MTC FIRST!)


Any leftover material will be stockpiled and used to resurface the rough portion of the Trail between Hendersonville and the National Tunnel.

Other plans include improving the Kurnick Parking Area; stream bank stabilization along McPherson Run near Hendersonville;

additional plantings and the creation of habitats for the fauna along the Trail. Some of this help will be provided through an Eagle Scout project; minor herbicide treatment of the Trail surface to keep it at its designed width of ten feet; and continuing to increase public awareness by setting up booths on the Trail on National Trail Day and other days and participating in the annual Indian Summer Festival.

The Moon/Robinson Friends of the Montour Trail are also planning an ambitious year. Their plans include: planting grass along the entire Moon/Robinson section; cutting weeds and grass up to five feet from the (beginning in April) so that they can share the limited Montour Trail edge of the Trail several times this year; install more benches at various locations; repairing streambank and other erosion problems; expanding and improving the Hassam Rd. (near the sewage treatment plant) and Groveton parking areas. They also plan a reprise of their highly successful Penny fundraising campaign of last year and will place occasional informational booths on the Trail and at various local community

The Findlay/N. Fayette Friends plan to begin the year with a much needed litter pick up campaign, particularly between the Parkway and the Cliffmine Rd. parking area. They will also complete a neighbor placating, tree planting project. The rest of their efforts this year will involve preparing the short section of uncompleted Trail, from the Boggs Rd. parking area to the Rt. 22 overpass near the McDonald exit, for final surfacing.

All of these groups meet on different Saturdays of each month Council equipment and supplies. Coordination will be critical this year because much of the equipment will be used every Saturday in the new construction taking place in Robinson, Washington County. Complicating matters even further is the fact that many regular members of the Friends groups have also committed themselves to the new construction project.



On Saturday, April 20, the Forest Grove Sportsmen's Association will hold its 7th annual Trout Fishing Tournament on the banks of the Montour Creek adjacent to the Trail. This year the Sportsmen plan to stock the stream with over 3,300 trout of all variety; rainbow, brook, brown, tiger, and others, all between 8" and 23".

Trophies and cash prizes will be awarded in the adult category for the top ten longest fish. Prizes in the children's category go to the top three finishers. Top cash prize is \$200. There will also be door prizes and a tag-fish kitty.

The day will begin with a pancake and sausage breakfast beginning at 5:00am. Price of the breakfast is \$3.00. The price of the tournament if you register before April 18, is \$10.00. After the 18th and including the day of the tournament the price is \$12.00.

All proceeds go to stocking the stream next year and for improving the creek as a natural trout habitat without the need for stocking every year.

Park Manor crossing on track for improvment

Design plans have been drawn up and moved past the approval phase at the Moon Twp. level to redesign the Trail crossing at Park Manor Blvd. and Montour Run Rd. below Robinson Town Centre. The next step is submittal to and approval by PennDot.

If the plans are approved then work can begin to remove the existing guiderail around the intersection so that the Trail can curved over to the regular crosswalk at the intersection. Trail users can then use the WALK/DON"T WALK signals that are already in place. Additional guiderail will have to be installed from the end of the Park Manor Blvd. bridge over Montour Run Creek around toward the present Trail surface to keep errent autos from going into the stream.

Bob Dudash, a member of the Moon/Robinson Friends group and an engineer for Michael Baker Corp. drew up the plans and will submit them to PennDot.

The Montour Trail Council will begin volunteer improvements and construction of the Trail in Robinson Township, Washington County on Saturday, April 6 at 9:00am. Work will continue every



Saturday thereafter until the section is completed. Bring your work gloves and meet us underneath the McDonald Trestle. Lunch and drinks will be provided. Please try to set aside at least one Saturday during April, May, or June to lend us a hand. You'll be glad you did!

"Spineline" group gets official name

The Spineline collection of the five trail groups involved in the Pittsburgh to Washington D.C. connection has finally decided on an official name. The Allegheny Trail Alliance is the moniker that will be used to present a united front to foundations and help them to prioritize grant money. The five groups involved are The Allegheny Highlands Trail; The Mon-Yough Trail; The Steel Heritage Trail; The Three Rivers heritage Trail; and The Montour Trail. The first task is for each individual group to come up with an estimate of how much

money it will take to complete each trail - task by task. Then ambassadors from each group will gather together to prioritize the tasks of each trail. Then, when foundations are approached for grants, they won't have to decide for themselves which project is more worthy of funding because the trail groups will have already figured that out amongst themselves.

The autonomy of each group will be maintained and other fundraising efforts will not be restricted in any way.




