# THE ATA "WORLD-WIDE" CONFERENCE

The members of the trail groups which form the Allegheny Trail Alliance met at St. Joseph's Center near Greensburg on January 29-30 to review a year of phenomenal progress, to discuss strategy for the year ahead, and to enjoy fellowship with each other on one of the few occasions when we all come together. Over one hundred fifteen persons attended, representing all of the trails in the Alliance, State and Federal agencies, and some non-ATA trails. Prior to the official opening, the ATA Board held its regular meeting. This was also attended by about twenty early arrivals, who listened attentively to

status reports on TEA-21 and Pennsylvania funding, progress of various segments, and plans for the June '99 International Conference in Pittsburgh.

First conference event was the Friday evening meal, followed by opening welcome by ATA President Linda Boxx. Featured speaker was Rick Sebak, well-known producer of documentaries for WQED, who described the challenges of creating his widely acclaimed features. Rick's talk was followed by several hours of unstructured fellowship while entertainment was provided by the Rail-Trail Ramblers (a lively folk

music group including MTC's own Bill Metzger).

Saturday's breakfast was followed by a general session to inform the ATA members of the opportunity to have the entire ATA trail designated as one of the trails in the National Trail System. Panel members included representatives from the PA Bureau of Parks and the National Park Service. It was noted that the trail from Washington DC to Ohiopyle is already designated as the Potomac Heritage Path. Attendees were urged to initiate discussion within their respective trail groups about the issue.

# And the survey says...

In July, 1997 the MTC conducted an extensive survey of trail users. Our goal was to find out who was using the Trail, how often they used it, why they used it, and what they did and didn't like about it. We wanted this information for several reasons. First, by understanding the Trail's con-

stituency we will be able to better manage the future Trail development. Second, we needed to provide these demographics to public and private agencies who fund the Trail. These agencies want to know that their money is being put to good use and that the Trail is being used by the

First of all we developed a questionnaire that captured the information we needed. We had volunteers stationed at strategic points along the trail in the Moon, Robinson, and Findlay areas.



# MTC 1998 Summary

New trail construction consisted of one (1) mile in South Park Township, another mile in Bethel Park and the Trail Head at Triphammer Road. The forecast for construction in 1999 appears elsewhere in this issue. Numerous significant events occurred also which are essential for engineering and construction to proceed this year and next.

Most significant was the campaign to gain funds from the Federal Government which resulted in a lineitem for same in the Federal Transportation Act (TEA-21) passed by Congress in June. Now, although matching funds will be required and certain criterion must be compiled with, the prospect for actually obtaining these funds is real and an encouraging timetable is set. (Goal - Pittsburgh to Washington, D.C. in 2001.) This was accomplished by substantial effort of some MTC volunteers and support and cooperation of the Allegheny Trail Alliance.

Simply put, \$3 million in Federal money will be available to meet the major construction challenges facing MTC. These funds coupled with those still available under the ISTEA program go a long way toward completing the Montour Trail in both Allegheny and Washington Counties.

To facilitate all this, PADOT has agreed that all ISTEA funds will be applied to projects in Allegheny County and administered by PADOT District 11 (Bridgeville). TEA-21 funds will be handled through PADOT District 12 (Uniontown).

This is intended to simplify and expedite all MTC projects.

A similar campaign on the State level, actually preceded the TEA-21 campaign, and it resulted in \$2 million being included in the 1999 State budget for trail development, a large part of which MTC is eligible to apply for.

Recalling that the Public Utility Commission (PUC) nearly 2 years ago ordered the removal of all highway crossing structures abandoned by railroad companies and that the MTC obtained a "stay" on that order until June of 1999 in order to prepare an argument for a decision more favorable to MTC's interests, a proposal has been drafted by MTC which incorporates the interests in this matter of PADOT, DCNR and the counties and municipalities involved. All interested parties are in the process now of "signing-off" on this proposal (mostly the product of MTC's attorney, Richard Wilson) with the objective of presenting it to the PUC in late March.

As in previous years, MTC and IKEA sponsored a half-marathon. However, MTC switched roles with IKEA, becoming the main conductor of the event, with IKEA remaining an important sponsor. The other usual fund-raising events were also held — the beer-pour at the Allegheny County Rib Cook-Off and the Christmas Tree Wrap. These kind of funds, like membership donations are used to cover administrative and operating expenses. They also provide beneficial publicity.

Heading the special events

of '98 is the coal stripping still underway in the Boggs Run area. Per the agreement entered into with MTC in early 1998, Amerikohl Mining, Inc. commenced the clearing for and the mining of coal in the Pittsburgh seam (which lies under MTC property between Boggs Run Road and US 22) in late October. This work is scheduled for completion in April of 1999 leaving MTC with a proper trail base across the work area and extending into the adjoining Champion property.

Another special event was the installation of two counters — one near mile 4 and the other in the Enlow vicinity near mile 8. Results indicate that between the end of July to the end of October, and average of approximately 2500 persons used the Montour Trail each week in the Park Manor Drive area, and 3200 in the Enlow section. The counts are being studied further.

Another study was conducted to determine the economic impact of Trail activities on adjoining communities, not only MTC but all the ATA members (from Coraopolis to Cumberland, MD). Just finished, the study report reflects well on the Trails program. An executive summary will be distributed soon.

Other newsworthy events include the repair of the Johnston Bridge deck in Mt. Pleasant Township, and the consent decree issued by the Court of Common Pleas, Washington County, affirming MTC's title to property in Cecil.

# Watershed plan being finalized

A draft version of the River Conservation and Land Use Plan for the Montour Run Watershed was issued for review and comment by Airport-area residents in December. The finalized version of this document will be the main product of the Montour Run Watershed Planning Project, which has been conducted for the Montour Valley Alliance by a team of professional consultants led by KCI Technologies, Inc.

The draft version of the Plan lists a total of 56 actions that can improve protection of the water, land, biological, cultural, recreational, and educational resources of the Watershed. Included are critical reviews of landuse patterns and zoning, as well as actions that would benefit the area's economy through recreation and tourism enhancements.

A scientifically based development capacity plan identifies where development can occur with best protection afforded to the Watershed's environmental resources and popular recreational areas. Protection of the more sensitive areas would ensure the continuation of recreational and economic benefits presently being derived from the Montour Trail and other resources. It would also help reduce future costs for stemming streambank erosion, repairing flood damage to public and private facilities, and removing siltation from streambeds.

The Plan defines a Riparian Conservation Corridor that is particularly vulnerable. This Corridor can be protected by enforcing existing ordinances that relate to tree cover, building coverage, and the disturbance of steep slopes, drainageways, and land-

slide-prone soils. Other means of protection could include the establishment of a Montour Greenway such as the Hollow Oak Land Trust has been advocating for several years. Through conservation easements, sensitive resources can be protected while lands remain in private ownership.

The final version of the Plan will be presented at a public hearing this coming spring. If the Plan is endorsed by one or more of the municipalities within the Watershed and is favorably received by the Pennsylvania Department of Conservation and Natural Resources, Montour Run will be placed on the Pennsylvania River Conservation Registry. This will make the 37-square-mile Montour Run Watershed eligible for state funding of implementation projects that should directly benefit all area residents and businesses.



# Board Briefs

Recent actions of interest by the MTC board:

Approved use of a frequently flooded portion of trail in Robinson Township, Allegheny County for an asphalt paving demonstration as part of the International Trails & Greenway Conference in June.

Received a report on the proposed allocation among trail organizations of Allegheny Regional Asset District money granted to the Allegheny Land Trust. The MTC could receive as much as \$30,000 from this fund.

Approved moving forward

with a required environmental assessment on trail sections to be developed in Peters Township.

Discussed trail-building goals for 1999. New trail is to be completed in three areas: Large to Clairton, Boggs Run to Quicksilver, and Cecil Park to Venice.

# Washington County bridge agreements near

The MTC's effort to retain as many as possible of the existing railroad crossings over state maintained highways and roads appears to be on the verge of modest success.

Over the last two years, the MTC has been contesting the state Public Utility Commission's attempts to have all these bridges removed. Since bridge replacement is among the most expensive aspects of trail construction, these removals would create major obstacles to trail development.

As a result of significant effort by MTC's legal counsel, Dick Wilson, the PUC's order was blocked and two state departments — Conservation and Natural Resources, and Transportation — agreed to conduct a reanalysis of

the bridges. Eighteen crossings were involved. The result is a proposal, prepared by Dick Wilson, that is being reviewed and which is likely to be submitted to PUC in late march for consideration and hopefully acceptance. The proposal covers the removal of some structures, the improvement of others and retention of the rest. (See PUC remarks under Prez sez.)

New legislation passed last fall will permit the PUC to transfer responsibility for these bridges to the MTC. To make this transfer feasible, a government entity is needed to take "secondary responsibility" for the bridges in the highly unlikely event that the MTC should become unable to maintain them.

The MTC met with all three Wash-

ington County Commissioners on January 21, and they expressed their strong support for the trail. We are hopeful that, in the near future, a formal "secondary responsibility" agreement will be completed and signed.

Many civic leaders deserve our thanks for helping us come this far. They include Washington County Commissioners Bracken Burns, Diana Irey, and Scott Fergus; County planning director Marlene Luketich; and County parks and recreation director Andy Baechle. In addition, DCNR Secretary John Oliver and PennDOT Secretary Brad Mallory have both supported and been personally involved in this precedent-setting negotiation.
