"DIG WE MUST" is a phrase often seen on signboards at construction projects. In our case, "DUMP WE MUST" would be more appropriate. Under a special agreement with MTC and with funding provided by Pennsylvania DEP, the Montour Run Watershed Association (MRWA) will be hiring a contractor to install carbonate rock linings in sections of the banks of Montour Run. This will be done to retard further erosion due to the increased runoff of storm water while helping neutralize acid from abandoned mine drainage. Particularly heavy scouring has been occurring along the main trunk of Montour Run, undermining the

wearing surface of Airportarea sections of the Montour Trail.

The only useable means of access to the areas that require stabilization is via the Trail. To protect the safety of Trail users during the construction period, the contractor will be placing barriers closing off certain sections to use by pedestrians and bikers. The closed-off sections will include Groveton to Hassam Road, short sections beneath the bridge on Beaver Grade Road and near Schmidt's Tavern, and Enlow Road to Five Points. At this time we don't know how many of these sections will need to be closed off simultaneously, but the planned period of construction falls within the month of June. MRWA regrets this disruption to routine Trail use but will appreciate the patience and cooperation of Trail users as we work to protect the stream banks.

Nearly 1300 lineal feet of rip-rap stone are to be placed at twelve designated sites along the main trunk of Montour Run. These sites are located in Moon and Findlay Townships. Allegheny County engineer and MTC Board member Dave Wright has been doing much of the work involved in obtaining permits and preparing bidding documents for this project.



... and the PREZ sez...

All of us were saddened by the tragic accident that took the lives of five persons in South Park a month ago, when a driver suf-

fered an aortic aneurysm and careened into the walkway that parallels Corrigan Drive.

Although very little of the Montour Trail parallels auto traffic as closely as does the Corrigan Drive trail, safety considerations are an important part of our management of this recreational resource. It is impossible to avoid all accidents - anything we do in life involves some risks. But, of course, we want to take all reasonable measures in order to minimize those risks. Here are a few of the many safety-related steps we have taken:

- Building a trail on former railroad rights of way where one is generally quite distant from auto traffic.
- Leaving as many grade separations (bridges and tunnels) in place as possible in order to avoid at-grade crossings (intersections).
- Putting barriers at all trail en-

trances, making it difficult to get on the trail with a vehicle without the correct key.

- Installing split rail fencing alongside the trail at a number of points.
- Setting up rules to follow while using the trail.
- Having monitors who regularly patrol various trail segments.
- Encouraging the local police to ride the trail.

We plan to rebuild as many grade separations as possible. As we have limited financial resources, we have to be selective in our planning and work on those locations with greater traffic volumes. In general, we would rather live with a less than optimal condition for a few years and then build it as safely as possible than to have a compromise solution that we have to live with into perpetuity. For example, rather than put an 'up-andover' trail (with an at-grade intersection) at the Triphammer Road crossing in South Park Township, we will wait until we can run the trail through an 18 foot diameter corrugated metal pipe under Triphammer Road and thus restore the grade separation.

Similarly, the Brush Run and Clifton Road crossings along the Bethel Branch are thought of as temporary situations.

High volume crossings where the railroad had no grade separation are particularly challenging. I am thinking of Park Manor Drive in Moon Township and PA 51 in Jefferson Hills Borough. No long-range plans for these locations have been laid out yet. For now, we will use existing traffic lights to help us cross safely.

Aside from intersections, we need to monitor the condition of physical barriers to ensure that they are still in good shape and have not physically deteriorated. And trail users need to observe and report unsafe conditions to the police and/or the MTC, as appropriate.

Finally, be a 'they', as in 'When are they going to do something about this unsafe condition?' Keep in mind that our volunteer or financial resources are limited. It is great if you bring a problem to our attention, but even greater if you are willing to offer some of your energy and skill to work with us toward getting it resolved.

ATA Conference - 2001

The Allegheny Trail Alliance held its second "worldwide" conference on February 9 and 10 at the St. Joseph's Center near Greensburg. All trails of the ATA were encouraged to have as many of their members attend as possible. The Montour Trail was represented by a dozen of our most active, including many present or past officers. Registration total was over one hundred persons, including invited guests. The first goal of the event was to bring the "in-the-trenches" workers of the various trail groups together with their counterparts to exchange notes, gain a sense of a common effort, and learn about how the ATA is progressing. Secondly, the Conference was intended to provide, from sources outside the trail groups themselves, information which would be helpful or of particular interest to trail builders.

Events began Friday evening with dinner in the St. Joseph's dining hall, followed by a keynote address by David Dionne, superintendent of the Baltimore & Annapolis Trail in Maryland. A most engaging speaker, he held attention by describing the development of the B&A Trail, how it had encountered opponents and converted them to supporters, and how extensive local support had beautified and helped to maintain the trail. He then moved on to describe his other passion, the East Coast Greenway - a

trail corridor from Maine to Key West (through New York City!) - which is steadily progressing. The Greenway will also pass through the District of Columbia, and in so doing will be linked by the C&O Towpath Trail to the ATA system. Following his remarks, the Mon-Yough Trail Council hosted a social evening with a lively band and lots of refreshments. This social, together with the meal events, provided attendees from the various trails opportunity to mingle, compare notes, and renew old acquaintances. The walls of the room were lined with exhibits brought by the various trail groups to show off their accomplishments.

Saturday morning's highlight was the unveiling of the logo adopted by the ATA for the Cumberland to Pittsburgh Trail as a whole. The name chosen (after literally years of discussion) is "Great Allegheny Passage," and the logo shows a trail beside a river passing through the mountains via a tunnel. The logo and name will be presented to the public as the beginning of a coordinated marketing plan. Expect to see it a lot! The new name and logo were well received and many of the older hands were happy to see an issue of long standing resolved. Of course, the individual trails of the ATA system will

retain their own names and logos for their respective portions.

Saturday then featured two separate periods of informational group presentations from which attendees could choose topics of interest. Among these were: "Rehab of Savage Mountain Tunnel," "Development of Informational Signs," "Developing the Trail as an Educational Resource," "Marketing the ATA as a System," "Why It Takes So Long To Spend Our Federal \$," and others. Everyone found the sessions they attended to be of value, and most regretted that the schedule only permitted attending

schedule only permitted attending their choice of two of the offered programs.

After the second of these periods finished, everyone gathered together for a concluding session. Each trail group was invited to present a "President's Award" to a member in recognition of outstanding service over the past year. Peter

service over the past year. Peter Kohnke presented the MTC's award to Dick Quasey for "contributions too numerous to mention". ATA President Linda Boxx gave concluding remarks, and was surprised by an informal award presented on behalf of the ATA Board. Following a group photo outdoors in a chilly breeze, the conferees dispersed to further the completion of the Great Allegheny Passage.

Panhandle Trail Association Forms

Trail surface renewed

Last year Trail users began to wonder when certain parts of the Montour Trail surface would be repaired. Wet weather and heavy Trail traffic have caused serious deterioration in some places. Members of the Robinson Township (Allegheny County) Public Works Department (RTPW) shared this concern.

In early March it was agreed that RTPW would place a new surface on the Trail in Robinson Township. MTC ordered sufficient surface material and delivered the material to two sites: first, to the Forest Grove Sportsmen's Club on March 14th; and then to the vicinity of the Old Beaver Grade Road parking area, which was recently acquired by the MTC with Dave Wright's help, on March 20th and March 26th.

Now the Montour Trail from Hassam Road (mile 1.4) to Park Manor Drive (mile 4.1) has a new look and is user friendly to walkers, hikers and bikers alike

Southview Bridge partly dismantled

Vandals reportedly dislodged part of a walkway on the Southview Bridge late last year. This bridge crosses SR 4039 near the community of Southview in Cecil Township. The result was a threat of a hazard to the vehicles using the road below.

Last January, signs were installed which state that the bridge is closed and plans were made to eliminate this risky situation. Winter weather and poor site conditions delayed remedial work until Wednesday, the 26th of March. That day a crew of seasoned Trail volunteers of Quick-silver Bridge fame (Tom Kaveney, Mitch Cholewinski, Joe Seibel, George Gerben, Ed Ritter, and Ken Gregory removed the walkways on both sides of the bridge, eliminating the threat to road traffic.

The bridge will remain closed until a new deck is placed on it later this year.

3rd Annual Yokatomac Trek - June 9 to June 17, 2001

The trail from Pittsburgh to Washington, DC is nearly finished!

Reservations are being accepted on a first come, first served basis.

Missing link lies in Mt. Pleasant

The Montour Trail winds through a dozen municipalities in its 47-mile stretch between Coraopolis and Clairton. So far, portions of the trail have been completed in all but one of those communities, Mt. Pleasant Township. But Mt. Pleasant's time is coming soon, as plans have been revealed to construct the unfinished sections of the trail in Washington County.

Last week, Mackin Engineering Co. of Pittsburgh submitted preliminary drawings for the design of the trail through Robinson, Mt. Pleasant, Cecil, and Peters townships.

The trail council is complemented by several "friends" groups that have helped drive localized volunteer efforts. The latest group to be formed, Fort Cherry Friends of the Montour Trail, soon will begin clearing trees, bramble bushes and weeds from the railroad bed in Mt. Pleasant. "It's pretty well grown over," said Joseph

Seibel, a member of the Fort Cherry Friends. "It has a lot of sapling trees growing in the right-of-way. They have to be pulled out and cleared away. This is the last section that has to be done." The Fort Cherry group, formed about four months ago, includes about 40 volunteers from Mt. Pleasant, Robinson and South Fayette townships, McDonald Borough and Seibel's hometown of North Fayette. The volunteers will be responsible for clearing and maintaining 4.7 miles of the former railroad that stretches from the McDonald Trestle, along Primrose Road, through Mt. Pleasant to the Cecil border. As part of the trail construction, the McDonald Trestle will undergo extensive refurbishing. Dennis Pfeiffer of Moon Township, past president of the trail council, said work on the trestle will include removal of railroad ties from the 967-footlong structure and the installation of a cement deck and railing.

At one point, all the bridges across road-

ways were to have been removed, as ordered by the state Public Utility Commission - including already-completed sections of the trail. The Montour Trail Council was successful in getting the state Supreme Court to reverse and remand the decision, and since then has been working with state agencies and local governments to develop a plan for maintaining some of the bridges.

Also included in the Mackin contract is completion of the unfinished portions of the Montour Trail in Peters Township, to link with the existing Arrowhead Trail, which is part of the Montour system but owned and maintained by the municipality.
