Bethel Trail construction has begun

A \$33,000 contract has been given to Ellis Asphalt Paving of Canonsburg by the Montour Trail Council to construct a 0.92 mile section of trail in Bethel Park. The work has started and is presently ahead of schedule. The contract calls for completion by November 15, but a ceremony for the official

opening of this section is currently being planned for the end of October!

The section being constructed starts just south of Clifton Road, crosses Limestone Drive, and ends at the Peters Township line. In spite of the name of the contractor, the surface of the trail will be finely crushed

limestone, as it is on other completed parts of the Montour Trail. This provides a good surface for pedestrian and bicycle activities.

The funds for this construction come the from Allegheny County Regional Asset District by way of the Allegheny

TRAIL SAFETY

Regrettably, no good thing can last forever. The Montour Trail Council and our affiliated Friends groups work hard to assure the safety of all trail users, but a recently reported assault -- the first serious incident in our six years of trail operation -- has led to renewed examination of the importance of trail safety.

One question dominates these discussions: What more can be done to assure the safety of every trail user?

• Practice safety in numbers

Local police departments advise walkers always to use a buddy system rather than walking alone.

• Promote the Trail

Increased use of the trail helps ensure its safety.

 Report unfavorable conditions or questionable activity

If you observe any potential hazards or unusual behavior around the trail, contact the local Friends group, a board member, or the MTC hotline. We are currently forming "trail monitor" teams to attend to such reports.

Comply with trail regulations, and encourage compliance by all trail users.

We intend to do our part by eliminating hazardous condition (whether resulting from storms, natural growth, wear and tear, or other causes) and maintaining volunteer patrols. You can help us keep the trail safe by using it properly, responsibly, and often.

Editor's Note: At press time, Dick is at home recuperating from his recent open heart surgery to replace a leaky valve. He continues to make great progress daily. "Keep it up, Mr. Prez!"

Bikers say: walkers must be safe too!

Last issue's article urging safer biking on the Trail provoked the biggest response we've had to any article in years. Happily, everyone recognized that our proposed solutions (e.g., signs reading "Surgeon General's warning: it is unsafe to pass on the right") were tongue-in-cheek. But beyond that, opinions diverged.

Several MTC members thanked us for asking bikers to be more careful. On the other hand, several pointed out that we shouldn't single out bikers as the problem, because walkers are often the cause of unsafe situations and accidents as well. We agree. To complement our advice to bikers, here are the most important tips walkers should observe:

- ⇒ Always stay to the right, walking no more than two abreast. If you stop for any reason, move to the edge of the trail; don't dawdle in the middle.
- ⇒ Teach children not to drop items on the trail or stop suddenly.
- ⇒ Keep pets leashed at all times.

One avid biker responded, "What's the point of having the Trail if I can't ride fast enough to get a good workout?" We want to be sympathetic to this concern, but it is hard for the

trail to serve as both a comfortable experience for leisurely travelers and a superhighway for two-wheelers.

Generally, the trail should accommodate moderate biking speeds, but if you really want to keep a faster pace than that, the paved roads may be better suited for your purpose.

We are happy to discover that so many people read our newsletter carefully, and hope to continue this dialogue in the interest of making our trail as safe and enjoyable as possible for everyone.

This year marked a change in the administration of the race, as IKEA wished to step back as the race organizer and assume a role less demanding of their personnel time. The MTC regards the race as the premier public participation event focused on the Trail, and stepped forward to assume the leadership role. IKEA remained as the major sponsor, most importantly providing valuable awards for the winners.

Race organization proved to be a more complex undertaking than we had realized while IKEA had that role! Thanks to a host of our loyal (and overworked) trail volunteers, everything from course certification to distribution of water along the course got taken care of. Land Trust, the Bethel Park Municipal Council, and a number of private donations. Some of this money was matched against the in-kind contributions by a large number of people and organizations that prepared the land.

The land is owned by Allegheny Power who has given the Montour Trail Council an easement to build and operate a trail on it.

To complete the Bethel Park Spur of the Montour Trail, future projects

--- trail construction on the 1.1 mile stretch between Clifton and Logan Roads

--- ramps on both sides of Clifton Road

--- a bridge over Clifton Road.

Also, the connecting piece of trail in Peters Township from the Bethel Park Municipal line to the completed Arrowhead Trail at Brush Run Road will need to be done.

These projects will be completed when funds become available.

For the fifth year the Montour Trail has recruited energetic hands from all over the area to serve as beer bartenders on behalf of the Mon-Yough Recreation and Cultural Council (MY-REC) to staff its chief fundraiser. Actually, all staffers at the Rib-Off (except police) are from various volunteer groups in the area, from band parents to cheerleaders.

And it becomes a fundraiser for us at the Trail. This year MTC workers staffed well over 600 "man-hours" on Labor Day weekend to help make the South Park stadium event a success. They often emerge tired and well "marinated" from beer splashings at the end of their shifts, yet enjoy working with each other, and knowing they are helping the Trail (which got a \$4,500 donation this year). Some of

our workers are "repeaters" and a few have worked each of the five years MTC has pitched in. A somewhat happy "problem" is that occasionally workers enjoy their first

shift so much they want to stay over for the next.

MY-REC, itself a non-profit organization, serves 18 communities in

often poorer sections of Allegheny County and offers 30 different free events such as Glenn Miller big band, Maureen Budway jazz, Mellon Jazz site, Caribbean music/food night and even ballet performances to people who would otherwise not have them available. Summer Wednesday nights in Riverfront Park in McKeesport are movie nights. complete with free popcorn! (There are no commercial movie theaters remaining in town.)

MY-REC created Rib Cook-Off as an event in 1987. Sharron Stepanovich, Executive Director of MY-REC, credits much of the event's success to the fact it is family and food oriented, and is again, non-profit. Measure its success by other "copy-cat" events (Butler, Westmoreland, etc.) that have popped up since, and by contrast are all for-profit.

Our volunteers are looking forward to next year and are glad to know they are helping the Trail and kindred MY-REC as well.

MTC at Car Cruise

The second annual Car Cruise, held by the West Ridge Community Christian Church in North Fayette, took place at the Enlow ball field from 1-5 p.m. on October 10, 1998. Meeting Addresses Montour Watershed Issues

At the second of four planned public meetings of the Montour Run Watershed Planning Project on September 28, residents explored issues affecting the future of the Pittsburgh International Airport area as a place to live and work. Breakout groups dealt with water, land, cultural, and biological resources as well as the economic impacts of tourism and recreation.

The attendees expressed concern that development that has occurred in the floodplains has caused increased frequency, duration, and intensity of flooding. They believe that the removal of forested streambank buffers has had an adverse effect on water quality, and they are concerned about the possibility of future landslides as a consequence of disturbing steep slopes. They feel that publicly funded infrastructure is fostering urban sprawl and that the economic value of open space is not adequately reflected in economic development strategies for the area. They also believe that the Watershed's resources have not been fully utilized for educational purposes.

Gus Drizos of KCI Technologies, leader of the team of consultants who are preparing the River Conservation and Land Use Plan for the Mon-

tour Run Watershed, explained how many of the groups' concerns could be addressed by the adoption of a continuous greenway extending along Montour Run and its tributary streams and cutting across municipal boundaries. The greenway would protect resources that are especially vulnerable with presentday land-use practices. Future meetings will deal with ways in which the greenway concept could be implemented and the impacts that it would have on the area's residents and businesses.
